

ORDINANCE NO. 22

AN ORDINANCE calling a special election for the purpose of submitting to the legal voters of the City of Drain, Douglas County, Oregon, the question of authorizing the Council of said City to transfer from the City Hall Construction Fund to the General Fund of said City the sum of \$5,042.37 said money to be used and expended in the construction of a new bridge across Pass Creek on B Street in said City, and declaring an emergency.

THE PEOPLE OF THE CITY OF DRAIN ORDAIN AS FOLLOWS.

SECTION 1. A special election is hereby called and shall be held in the City of Drain, Douglas County, Oregon, on the day of 1941, for the purpose of submitting to the legal voters of said City the question of authorizing the council of said City to transfer the sum of \$5,042.37 from the City Hall Construction Fund to the General Fund of said City to be used and expended in the construction of a new bridge across Pass Creek on B Street in said City of Drain, Oregon.

SECTION 2. The polling place hereby designated shall be the City Recorder's Office, City Hall in the City of Drain, Oregon, and the Judges and Clerks hereby appointed to conduct said election shall be as follows.

SECTION 3. The form in which said proposed question shall be submitted on the official ballot of said election shall be as follows.

PROPOSED BY THE COUNCIL

Shall the council of the City of Drain, Oregon, be authorized to transfer the sum of \$5,042.37 from the City Hall Construction Fund to the General Fund of said City, to be used and expended in the construction of a new bridge across Pass Creek on B. Street in the City of Drain, Oregon.

Mark X between the number and answer voted for.

- 300 Yes, I vote for the transfer
- 301 No, I vote against the transfer.



SECTION 4. Said election shall commence at 9 o'clock A.M. of said day and continue until 6 o'clock P.M., provided however that the Judges in their descretion shall have power to adjourn one hour at noon, due procalamation being made of such adjournment.

SECTION 5. The City Recorder of the City of Drain, Oregon, is hereby authorized and directed to give notice of said special election in the manner provided by the charter of said city and the laws of the State of Oregon, and is also hereby required to furnish the necessary supplies for said election.

SECTION 6. WHEREAS the present city bridge across Pass Creek on B Street in the City of Drain, Oregon, is in such condition on account of age and long use that it has become worn out and in poor condition, therefore it is hereby adjudged and decreed that it is necessary for the immediate preservation of the peace, health, safety and interest of the City of Drain, Oregon, and the inhabitants thereof that the provisions of this Ordinance become at once effective, an emergency is hereby declared to exist and this Ordinance shall take effect and be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
