ORDINANCE NO. 135

AN ORDINANCE AUTHORIZING THE MAYOR AND THE COMMON COUNCIL TO ENTER INTO A LEASE AGREEMENT WITH R. A. BEEBE AND CHRISTINA BEEBE, HIS WIFE, FOR LEASE OF SOUTHEAST QUARTER, SECTION 18, TOWNSHIP 21 SOUTH, BANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, STATE OF OREGON, FOR A PERIOD OF TEN YEARS FOR CITY DUMP GROUNDS, IN ACCORDANCE WITH LEASE, COPY OF WHICH IS HERETO ATTACHED, MARKED EXHIBIT "A" AND MADE A PART HEREOF.

AHERRAS negotiations have been had with ones R. A. BEEBE and CHRISTINA BEEBE, his wife, for the rentak of the hereinafter described real property for the use of the City of Drain for city dump grounds upon the terms and conditions hereinafter set forth, for a period of ten (10) years at the rental of \$25.00 per year; and

WHEREAS the Common Council believes that said agreement is acceptable.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF DRAIN ORDAIN AS

Section 1: That the Mayor and the City Recorder of the City of Drain be and they are hereby authorized and empowered to enter into a written lease agreement with R. A. BEEBE and CHRISTINA BEEBE, his wife, for the rental of the rental of the following described premises, te-wit:

Southeast Quarter, Section 18, Township 21 South, Range 5 West of Willamette Meridian, Douglas County, State of Oregon.

for City dump grounds, for a period of ten (10) years from the 5th day of May, 1946, to and including the 5th day of May, 1956, at an annual rental of \$25.00 per year.

Section 2: The Mayor and the City Recorder are hereby authorized and empowered to enter into and do each and every act and thing necessary to consummate and close said rental agreement.

EXHIBIT "A"

DUMP GROUND LEASE

THIS INDESTURE OF LEASE, Made in duplicate at Driin, Douglas County, Oregon, on this 6th day of May, 1946, by and between 6. C. BEEBE and CHRISTINA BEEBE, his wife, of Drain, Douglas County, Oregon, hereinafter called the lessors, and CITY OF DRAIN, a municipal corporation, hereinafter called the lessee.

WITNESSETH:

That for and in consideration of the covenants, agreements and stipulations herein contained, on the part of the said lessee to be paid, kept and faithfully performed by said lessee, the said lessors do hereby lease, desire and let unto said lessee those certain presises known and described as follows, to-wit:

Southeast Quarter, Section 18, Township 21 South, Bange 5 West of Willsmette Meridian, Douglas County, State of Oregon.

TO HAVE AND TO HOLD said premises hereby leased for a period of ten (10) years from the 6th day of May, 1966, to and including the 5th day of May, 1956, said lessee paying and yielding as restal therefor during said term the sum of \$25.00 per year, \$85.00 having been paid on the signing and execution hereof, the receipt of which is hereby acknowledged, and the remainder of said payments to be paid on the 6th day of May of each year thereafter in advance, and all of said payments to be made at the City Recorder's Office, Drain, Douglas County, State of Oregen.

It is expressly understood and agreed that said presises are being leased for dump ground purposes, and that the lessee has the right and privilege of causing debris, refuse of all kinds and nature from the City of Drain to be dumped on said presises, cared for and disposed of, and that the payment of the aforesaid rent is payment in full for any and all desages to said presises and/or the use thereof.
