

ORDINANCE NO. 250

AN ORDINANCE LEVYING A SERIAL TAX OUTSIDE THE LIMITATIONS IMPOSED BY ARTICLE XI., SECTION II OF THE OREGON CONSTITUTION, FOR A PERIOD OF FIVE YEARS FOR THE PURPOSE OF CONTINUING TO IMPROVE, REPAIR AND MAINTAIN THE SEWAGE SYSTEM, THE WATER SYSTEM AND STREET SYSTEM, ALL WITHIN THE CORPORATE LIMITS OF THE CITY OF DRAIN, AND DECLARING AN EMERGENCY.

WHEREFORE, the budget of the City of Drain for the fiscal year July 1, 1978 through June 30, 1979 calls for a tax levy of \$40,000.00 against all taxable property within the City of Drain for the purpose of deriving funds necessary to carry on the functions of the city government; and

WHEREAS, the tax levy within the limitations of Article XI., Section II of the Oregon Constitution is not sufficient for raising the funds necessary to carry on the regular functions of the city and to meet the expenses for continuing a program of improving, repairing and maintaining the sewage system, water system and street system all within the limits of the said city; and

WHEREAS, there was submitted to the electors of the City of Drain at a special election on June 6, 1978 for their approval or rejection the following proposition:

"Shall the City of Drain of Douglas County, Oregon, levy a serial tax outside the limitation imposed by Section II, Article XI, Oregon Constitution in the sum of \$125,000.00 by a serial levy in the sum of \$25,000.00 each year for a period of five years commencing with the fiscal year 1978-79?"

and,

WHEREAS, at said regular election there were cast 66 ballots in favor of said proposition and 52 ballots against said proposition and that said proposition carried and said election was in all respects regular and according to law;

NOW THEREFORE, The City of Drain ordains as follows:


Section 1. That the City of Drain, Douglas County, Oregon, hereby levies a serial tax against all taxable property within the corporate limits of the City

of Drain outside the limitations imposed by Article XI., Section II of the Oregon Constitution in the sum of \$25,000.00 each year for a period of five years commencing the fiscal year July 1, 1978, for the purpose of continuing to improve, repair and maintain the sewage system, the water system and the street system, all within the corporate limits of said City.


Section 2. It is hereby declared that a public necessity exists and an emergency is hereby declared to exist, and this ordinance shall take effect immediately upon its passage and approval by the Mayor.
