AN ORDINANCE FIXING ELECTRICAL RATES AND AMENDING ORIGINAL ORDINANCE # 264 AND ORDINANCE # 291 AND REPEALING ORDINANCE # 296 AND # 280.

Energy Charge: All KWH per month @ 4.22¢ per KWH

Schedule SL-3, Street and Highway Lighting, Section 7.4553 is amended to read as follows:

7.4553 Rate

Basic Charge: \$ 11.00 (No KWH'S included in basic charge)

Plus

Energy Charge: All KWH per month @ 3.5¢ per KWH

Section 6.

Schedule YL-3, Security and Outdoor lighting, No change at this time.  
(See Ordinance # 301)

Section 7.

Schedule I-3, Swimming Pool, is amended to read as follows:

7.4663 Monthly Rate

Basic Charge: \$ 11.00 (No KWH's included  
in basic charge)

Energy Charge: All KWH per month 3.5¢ per KWH
