AN ORDINANCE REGULATING "B" STREET MUNICIPAL PARKING LOT; ADDING DRAIN TRAFFIC CODE SECTION 5.250; AMENDING DRAIN TRAFFICE CODE SECTION 5.900 (2)

THE CITY OF DRAIN DOES ORDAIN AS FOLLOWS:

*

<u>Section 1</u>. The following sections are hereby adopted as part of the Drain Traffic Code:

5.250. Parking and Standing - B Street Parking Lot.

- (1) Except on such days and upon such terms as may from time to time be set by resolution by the City Council, no person shall park a motor vehicle or trailer upon the "B" Street parking lot provided by the City between the hours of 12:01 a.m. to 7:00 a.m. of the same day except as provided in subsection (2) hereof.
- (2) The City Administrator or a person designated by the City Administrator may issue parking permits which, while valid, shall entitle the motor vehicle or trailer upon which the same is placed to park in the "B" Street parking lot between the hours described in subsection (1) of this ordinance. The conditions for the issuance of such permit shall be as follows:
 - (a) The permit shall be issued for each vehicle unit as defined in subsection (3) of this ordinance.
 - (b) Permits may be acquired for one month to one year from the date of issuance and for the period of time stated on the permit.
 - (c) Permits shall be placed on the vehicle unit so as to be plainly visible from outside the vehicle.
 - (d) A fee of \$ 10.00 per month shall be charged for each permit.
 - (e) Nothing herein shall be construed as allowing any vehicle to be operated or parked in any manner in violation of law, or any parking requirement of this article excepting only the specified limits of time.
 - (f) No permit shall be issued to a person unless the person first signs an agreement waiving any and all liability of the City for damage to the motor vehicle, trailer, or the contents of either occuring while the motor vehicle or trailer is parked on the "B" Street parking lot.
 - (g) If the Council by resolution declares a public need for temporary use of the "B" Street parking lot, any permits then in force shall be temporarily suspended during the period of public need.

a.	Semi-Tractor	l Unit
b.	Semi-Tractor and One Trailer	l Unit
c.	Semi-Trailers	l Unit
d.	Two Semi-Trailers	2 Units
e.	Semi-Tractor and Fwo Trailers	2 Units
f.	Motor Car or Truck	l Unit
g.	Motor Car or Truck and Trailer	l Unit
h.	One Trailer	1 Unit
i.	Other Individual Pieces of Equipment	l Unit Each

- (4) Except to park or remove a motor vehicle or trailer, no person shall enter or remain in or upon the "B" Street parking lot between the hours of 12:01 a.m. and 7:00 a.m., unless otherwise specifically authorized by resolution of the City Council.
- (5) No person shall repair, perform maintenance upon or otherwise work upon a motor vehicle or trailer parked in or upon the "B" Street parking lot.
- Section 2. Drain Code Section 5.900 (2) is amended to read as follows:
 (2) Violation of Sections 5.100 to 5.125; 5.135 to 5.150 and 5.250 are punishable by a fine not to exceed \$ 100.00
