A RESOLUTION AMENDING LAND USE AND PLANNING FEES

WHEREAS, Ordinance No. 321 amending the Drain Comprehensive Pan provides that land use and planning fees are set by Resolution; and

WHEREAS, it is deemed reasonable to amend said land use and planning fees periodically to reflect the costs of providing services; and

WHEREAS, the Drain City Council finds the following land use and planning fees are necessary to cover the City's cost of providing these services; and

WHEREAS, the Drain City Council has provided an opportunity for public comment on the proposed increase, as required by ORS 294.160.

NOW, THEREFORE, BE IT RESOLVED, that the following land use and planning fees are hereby adopted by the Drain City Council:
